Though, the therapists familiar with these issues have told me that potty training children are at risk for sexual abuse.

I want to ensure you again that we are committed to giving the parents of children harmed the best possible information so they can properly care for their child. If this investigation reveals enough evidence for additional criminal prosecution, we will present the information to the district attorney's office for prosecution.

Detective xxxxxxxxxxxxxxx informed me that she would be the detective looking over the case. She asked me about information so that she could be prepared when she spoke to people at the church. She was asking about volunteers and how they were kept track of.

I replied back the same day that the year runs from August to August. Volunteers are expected to commit for a year.

She said that she had looked into the file and that there was also something in the plea deal that might prevent future prosecutions. It seemed like Detective's intent in taking over the case was to bring me some sort of peace in the unknown. I was kind of confused about this, because I don't think that was a police detective's job. She got out a notepad and started to write down goals out of our time together. This was also confusing. If she was not able to pursue prosecutions, why would she be writing down goals? I told her that I was concerned about the conduct of the adults in the situation. At this point, she gave a strong defense of Original Detective, stating that she had known him for a long time and that he had integrity, etc. It was very much in line with the defense that Captain CID gave for Original Detective in a prior email. She was interested in names of parents from the class. She said that she could legally demand

that information from the church, but wanted me to provide her with information.
